控煙政策 Tobacco Control Policy


- 循序漸進 Progressive approach
 - 不鼓勵吸煙、抑制煙草的廣泛使用、盡量減低二手 煙對公眾的影響

To discourage smoking, contain the proliferation of tobacco use and protect the public from second-hand smoke to the maximum extent possible

- 多管齊下 Multi-pronged approach
 - 立法、執法、宣傳教育、推動戒煙、徵稅

Legislation, enforcement, publicity and education, promote smoking cessation and taxation

吸煙(公眾衞生)條例 Smoking (Public Health) Ordinance

- 香港法例第371章
 Law of Hong Kong, Cap. 371
- 1982年制定,歷經多次修訂,最近一次主要修訂於2006年進行
 First enacted in 1982 with several amendments subsequently, latest amendment in 2006
- 香港最主要的控煙法例框架:
 Major part of the legal framework on tobacco control in Hong Kong:
 - 法定禁煙區Designated No Smoking Areas
 - 管制煙草產品的銷售Restriction on sales of tobacco products
 - 一 管制煙草產品的廣告及推廣
 Restriction on tobacco advertising and promotion

法定禁煙區 Statutory No Smoking Areas

由2007年1月1日開始,法定禁煙區範圍分階段擴大至所有室內工作間,公眾場所內的室內地方及部份戶外地方

From 1 Jan 2007, no smoking areas have been extended to all indoor areas in workplace and public places, and some outdoor areas in phases

定額罰款(吸煙罪行)條例 Fixed Penalty (Smoking Offences) Ordinance

- 香港法例第600章
 Law of Hong Kong, Cap. 600
- 於2009年9月生效
 Effective since Sep 2009
- 任何人在法定禁止吸煙區吸煙或攜帶燃 著的煙、雪茄或煙斗會被<u>罰款港幣</u>
 1,500元

Anyone who smokes or carries a lighted cigarette, cigar or pipe will be liability to <u>a fixed penalty of</u> HK\$1,500



其他控煙規定 Other Tobacco Control Regulations

- 煙草廣告 Tobacco Advertisement
 - 禁止所有電視、電台、電影、互聯網、文字媒體及小販攤檔的 煙草廣告
 - Prohibit tobacco ad in TV, radio, films, internet, printed media and hawkers
- 健康忠告 Health Warning
- 禁止售賣或給予煙草產品予18歲以下人士Prohibited sale of tobacco to people under age 18
- 不得以自動販賣機售賣任何煙草產品
 Prohibited selling of tobacco products through vending machines

衞生署執法隊伍 Enforcement Team

- 根據《吸煙(公眾衞生)條例》委任及授權 Appointed under, and empowered by, the Smoking (Public Health) Ordinance
- 執法範疇 Areas of enforcement
 - 禁煙規定、取締非法煙草廣告、執行禁止售賣煙草產品予18歲以下人士
 Smoking ban, prohibition of tobacco advertisement, prohibition of sale of tobacco products to minors

新措施:新增禁煙範圍 New Measures: New No Smoking Areas

• 非吸煙人士在隧道出入口範圍排隊候車時沒有辦法採取有效措施阻隔 二手煙

Non-smokers waiting and queuing for change of bus at bus interchange (BIs) at tunnels portal areas are unable to take any effective measures against second-hand smoke

• 八個隧道入口範圍內的巴士轉乘處及毗連的設施在2016年3月指定為 禁煙區

Bus interchanges and adjoining facilities located at eight tunnel portal areas were designated as statutory no smoking area in








新措施:擴大煙草產品上的健康忠告 New Measures: Expanding Health Warnings on Tobacco Products

- 健康忠告圖像的面積由至少佔煙草產品封包的50%擴大至85%
 Increase the area of the graphic health warning that covers from at least 50% of the packet to 85%
- 健康忠告的式樣數目由六個增加至十二個
 Increase the number of form of graphic warnings from 6 to 12
- 加入戒煙熱線Include quitline












